COMMUNITY

Cardiac Telemetry System:
Advanced remote monitoring capabilities track hospitalized patients from a centralized location for quick response to troubling changes in heart rhythm in a range of patients including cardiovascular, neurovascular, respiratory or any ICU/high-risk patient. Centralization also reduces patient transfers to different rooms as monitoring happens in any room.

Expanded Cardiac Care Unit
Mills-Peninsula patients having any procedure in the cardiac catheterization lab can be accommodated in the larger unit with dedicated nursing staff. The **expanded unit with 35 beds** can also receive patients from other Sutter affiliates or community hospitals who need access to this award-winning care.

Cardiac Excellence:
Mills-Peninsula performs **1,500+ cath lab procedures each year**. Multispecialty and subspecialty teams offer less invasive, safer alternatives to traditional surgery for diagnosing and treating heart conditions. This team will benefit from the expanded Cardiac Care Unit.

ENT Micro-debriider:
Secured through greatest need gifts provides a new generation airway tool for safe, rapid and effective removal of obstructing tissue from central airways.

Orthopedic Excellence:
Mills-Peninsula continues with a new spine and surgery table that supports precise intraoperative spinal adjustments. Used for spinal fusions, decompressions and laminectomies, more patients can also be served with the new equipment. An **Arthroscopy Tower** system is also in place to increase capacity to help orthopedic and sports medicine patients.

Enhanced Bone and Metabolic Health:
New low dose radiation imaging technology delivers exceptionally precise data on soft tissue and bone composition for patients. One of the Grants & Disbursements winners, this medical technology is also shortening wait times for radiology appointments.

3T MRI unit:
Latest generation MRI was successfully supported by community gifts in 2022 and will provide more detailed imaging and serve more patients more quickly. **\$711K from the Women's Health Luncheon and Lecture** was instrumental in completing this fundraising.

Pregnancy Care Companion App:
Personalized pregnancy care to track key milestones and automatically receive timely health reminders and educational materials. 2 out of 3 expectant mothers across the system enrolled, lowering the volume of messages to care teams by 16%. Donor gifts expand the app with resources for vulnerable populations as part of our mission to leverage technology to reduce health disparities and ensure more equitable outcomes, screening for perinatal mental health signs to follow at-risk groups.

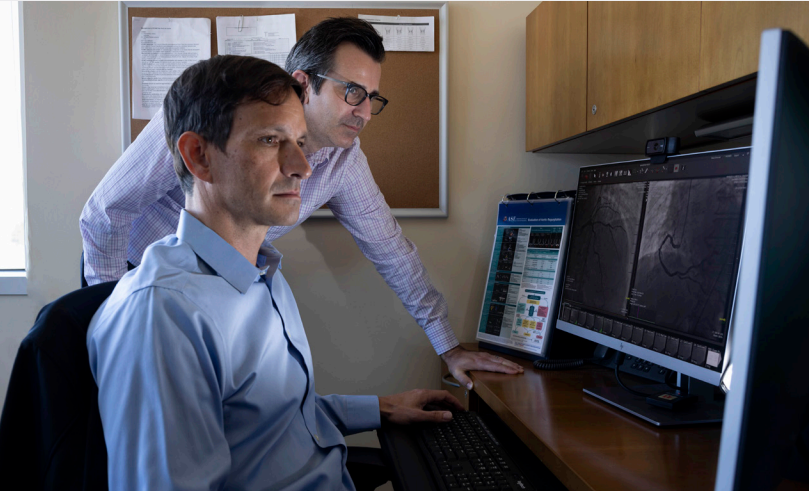
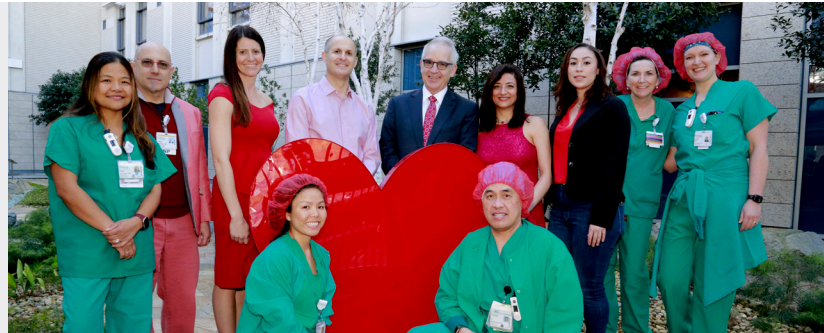
Mobile Stroke Unit:
Published research continues to show clinical benefits from **accelerated stroke treatment** which leads to less disability among stroke patients. Little or no disability after stroke also leads to lower financial burdens from rehabilitation or missed work to patients and communities. Philanthropic gifts made this the first **and only** MSU in Northern California.
