ANNUKUN

Iei annukun ewe Sutter Health an epwe awora ngeni patients ar repwe weweiti met mei maketiwi fanitan ewe Financial Assistance an epwe awora (income-based Financial Assistance) ukukun met en mei tongeni meeni anongonong on omw moni tonong ika (Charity Care) pekin aninis an epwe wor mumuta ngeni ekkewe patients.

AUKUKUN

Ei annuk mi apply ngeni meinisini ekkewe pioing mi wor nour licensed ir mi nom fan nemenian Sutter Health ika ewe Affiliated Entity (ei kapas mei awewe me non ewe annukun Sutter Health), me pwan ekkewe ekkoch pioing ikewe Sutter Health ika ewe Affiliated Entity mei wor ar nemenem ren ar repwe forano ika aukano ar angang ren met ir mei angei mei watte seni 50% (ren ei mei wewe ngeni ewe "Pioing" ika "ekewe Pioing non Sutter Health" (usun mei affatetiwi non Appendix G). tori minne epwe weseni affatetiwi, ei annuk esapw ngeni physicians, ika ekkewe ekkoch chon awora pekin safei, mei pachenong emergency room physicians, anesthesiologists, radiologists, hospitalists, pathologists, etc., pwan an io me io angang ese pachenong non ei taropwen pioing.
