Question of the month:

- Q. Is Sutter Health allowed to have Plan Reviews performed "inhouse"?
- R. Yes, DRA has approved Sutter Health to have the Sutter Health Accessibility Architect conduct plan reviews for the following project types:
 - Electrical outlet installa-
 - Minor equipment replacement such as Omnicell, Pyxis, Blanket Warmer, Vending Machine or ATM
 - Minor barrier removal modifications such as lowering counter heights
 - Toilet room remodels if not part of a larger project
 - Exam room remodels not exceeding 5 rooms

Please note that this option is reserved only for small projects with tight project timelines where a third-party plan reviewer is unable to meet the timeline. It is also dependent on the Sutter Health Accessibility Architect's current work load. The required monitoring process is unchanged.

Please contact Burnette Allen (916-566-4825) if you would like this option considered for your project. This is indicated as "OTC: Over-the-Counter" review on the plan review application.

"ROBUST" ACCESSIBILITY PLAN REVIEW

As you all know, Class Counsel has approved two methods for accessibility plan review and monitoring: 1) separate <u>Accessibility Plan Review (APR)</u> & <u>Monitoring</u> and 2) <u>Alternate Compliance Method (ACM)</u>. Because the accessibility reviews for the required APR/Monitoring process are limited, project teams have found this process too risky. However, project teams have also found the required documentation in the ACM process too burdensome. Therefore, we recommend what is informally called the "Robust" Accessibility Plan Review where the access specialist provides additional consulting services beyond the required APR/Monitoring process.

Additional services from the access specialist can include:

- 1. Preliminary reviews of floor plans/construction documents that are not yet 90% completion. Identification of common issue areas.
- 2. Responses to specific questions from the project team that are not within the official plan review process.
- 3. Preliminary site visits prior to official monitoring.

The "Robust" APR allows the project teams to decrease risk of accessibility barriers by identifying them earlier in design and construction. Please contact <u>Burnette Allen</u> (916-566-4825) if you feel that your project will benefit from the "Robust" APR.
