## LABORING OVER COMPLIANCE

Barrier Prevention is one of the main focus of the Consent Decree. FPD PAC facilitates this part of the program through the accessibility plan review process as well as the monitoring of completed work. As construction projects are being completed more monitoring will start to take place. However, items identified during monitoring reflect a failure in the plan review process. The cost and troubles to remove barriers after construction will be significant particularly if this phase is to be used as the primary method for preventing future barriers. The best and most practical prevention happens during the accessibility plan review.

This month we're providing a list of a few Path of Travel comments typically issued by our reviewers. Signage and interior comments will be highlighted in future publications. Be aware that this list is no substitute for proper design and due diligence but rather a tool for providing additional awareness.

8.	Provide door maneuvering clear spaces. The floor or ground area within the required clearances shall be level and clear.	1133B.2.4.2 and Figure 11B-26A
